Sub: Generation Tariff and Associated terms and conditions as approved vide Order dated 27 November 2017 of the Hon'ble West Bengal Electricity Regulatory Commission

1. Hon'ble West Bengal Electricity Regulatory Commission in terms of its (Terms and Conditions of Tariff) Regulations, 2011, has determined the Annual Capacity Charge and Energy Charge for the generating station of Haldia Energy Limited (in short 'HEL') for the year 2017-18.

Tariff recoverable by HEL for the year 2017-18 is:

Year	Annual Capacity Charge Recoverable* (Rs. Lakhs)	Energy Charge (Paisa/ kWh)

**Capacity charge recovery is at target normative availability of 85%*

2. The above Annual Capacity Charge recoverable by HEL from CESC Limited shall be on monthly basis depending on actual availability during the month with reference to the target normative annual availability subject to the conditions as laid down in the regulation 6.11.4 of the Tariff Regulations.
3. The tariff for 2017-18 shall be applicable from 1st April, 2017. Adjustments, if any, for over recover/under recovery from CESC Limited for the period from 01.04.2017 to 30.11.2017 shall be made in the monthly bills in 8 equal instalments commencing from the billing month of December, 2017. This rate will continue till further order of the Commission.
4. There will be no separate Monthly Fuel Cost Adjustment (MFCA) for HEL on and from 01.04.2017 till November, 2017. The MFCA realized by HEL during the year 2017-18 (upto November, 2017) will be adjusted in computation of any adjustments for over recovery/ under recovery from CESC Limited. HEL, shall, however, be entitled to realize MFCA for any subsequent period after November, 2017 as per provision of the Tariff Regulations.
5. CESC Limited may pay additional instalment on account of any arrear of HEL in any month and such payment will then be considered as payable in that month.
6. Any matter, which has not been explicitly mentioned in this order, shall be guided by regulations 2.9.8 and 2.9.9 of the Tariff Regulations.
7. For merit order dispatch, SLDC/ ALDC shall consider the energy charge of the generating station of HEL as determined in this tariff order as per the following table prospectively. The merit order

despatch as per the table below will be applicable from the date of issue of this order. However, the MFCA declared after this tariff order will be added to the energy charge for consideration of merit order despatch from the date of issue of the MFCA notification respectively.
